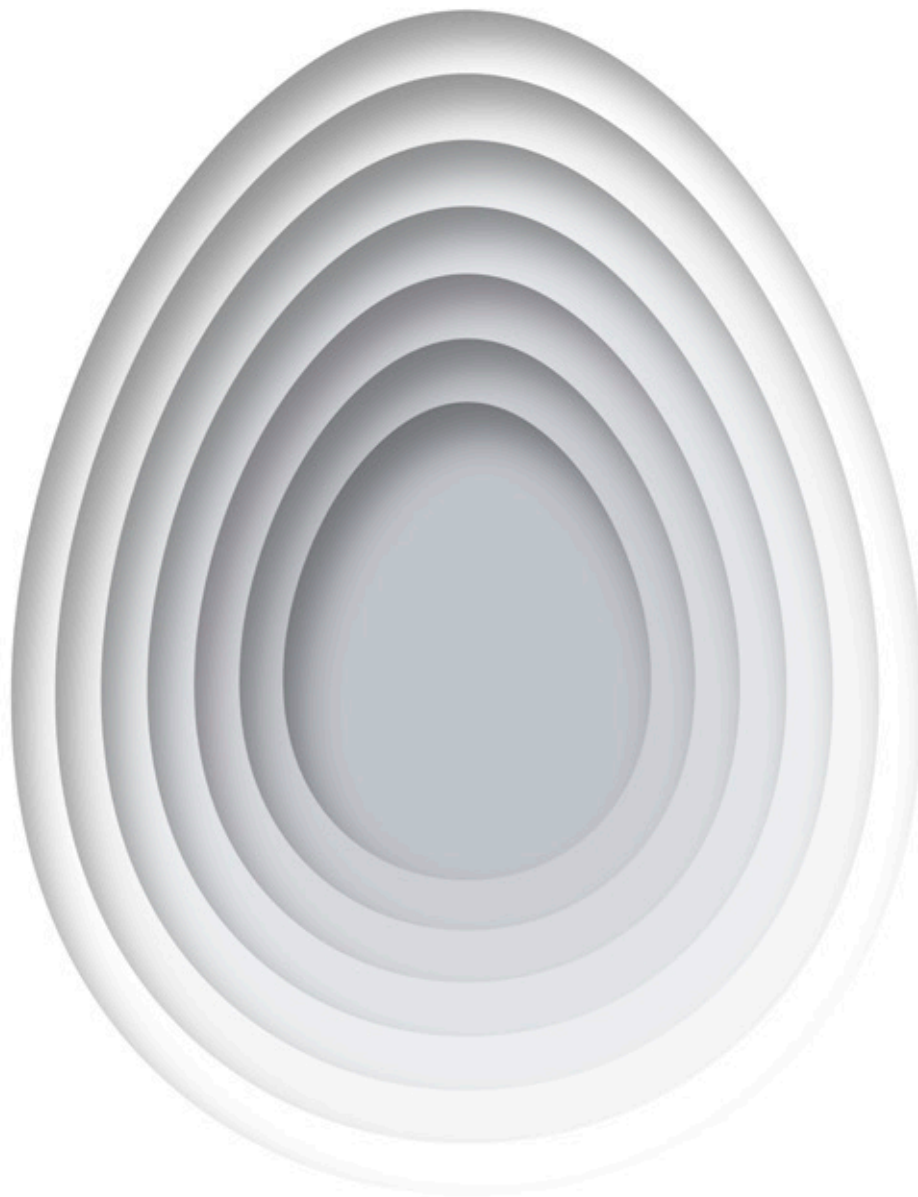

## PARTICIPATION TERMS AND CONDITIONS

The REGISTRATION FEE is € 600 (+ 10% VAT, total € 660) and has to be paid by all participants regardless of the size of the space hired.

The REGISTRATION FEE includes: opening of the dossier, Access to the EXHIBITOR'S AREA (private area with all the information and tasks needed to manage your participation in the trade fair), listing in the EXHIBITOR AND PRODUCT CATALOGUE, Access to the matchmaking platform (a tool created to request meetings with Hosted Buyers), free Wi-Fi access, 4 exhibitor passes, 40 single-use electronic invitations (additional exhibitor passes and invitations will be assigned based on the hired sq.m).

Upon sending the Participation application form, the designated Contact person for the trade fair will receive a welcome to Alimentaria FoodTech email with a link to the EXHIBITOR'S AREA platform. Once the exhibitor has accepted the participation proposal, the Organisation shall issue the invoice for the registration fee together with the first invoice for participation in accordance with the corresponding invoicing plan.

### Cancellation of participation by the exhibitor.

Exhibitors may cancel their participation in writing (registered mail, bureaufax or any other means that allows proof of sending and receipt).
