

ACCESS RULES TO THE EXHIBITION

Gastronomic Forum Barcelona is a specialized trade fair, aimed at an expert and prescriber audience, serving as a meeting point for professionals in the gastronomy industry and the entire value chain of the Foodservice sector (manufacturers, distributors, restaurateurs, etc.).

Registering in the **Gastronomic Forum Barcelona** accreditation system automatically implies acceptance of the following rules and Fira de Barcelona's refund and cancellation policy:

- **Exclusive access for professionals.** Access to **Gastronomic Forum Barcelona** is limited to professionals from the gastronomy and Foodservice sectors during the event days and within the established hours.
- **Online Registration.** The acquisition of the entrance badge will only be through the online registration system through the official website of the show. The system does not accept changes or refunds of badges under any circumstances.
- **Restrictions for minors under 18.** Minors under 18 years old are not allowed to enter, either alone or accompanied.
- **Exception for workers under 18**. Minors under 18 who prove their status as employees of an exhibiting company may access the exhibition to carry out their professional activities. However, the sale and consumption of alcohol to minors under 18 years old is strictly prohibited, regardless of their worker status.
- Entry for women with breastfeeding infants. Exceptionally, and only during the event period, the Organization will allow the entry of breastfeeding women with babies of up to one (1) year of age, to facilitate the work-life balance for women professionals in the sector.
- **Personal and non-transferable badge.** Entrance badge is individual and nontransferable for all event attendees. It is mandatory to always have the badge/entrance available. In case of loss, the attendee must go to the registration front desk (with the corresponding identification) to have their badge reprint/resent. The accreditation can also be reprinted through the official event website, in the "Registered Users" section.
- Access control system. Gastronomic Forum Barcelona uses and Anti Passback access control system, which prevents a badge from being used on more than once to access the trade show venue without having previously exited. Any attempt of fraud shall result in the withdrawal of the said registration by the Organizers.

• Professional activity verification:

• **Official identification**. For security reasons and always, attendees must carry their official photo ID (National ID Card or Passport), as well as the corresponding badge for the trade show.

At any time, the Organization may carry out identity checks and will be able to request both visitors and exhibitors to show their required official identification. These checks may be carried out, among other cases, at the time of collecting the official badge, at the access controls to the fairground and even inside the venue both during the assembly and dismantling phase and during the trade show days. If having made the relevant checks the identity of the holder of the official badge does not match his or her identity document, the Organization reserves the right to withdraw the badge, and the said person must therefore leave the trade show venue immediately.

• Miscellaneous provisions:

- **Right of admission.** Organizer reserves the right to admit participants and to withdraw their registration for non-compliance with the Rules of Participation and the Rules of Access to the Trade Show, without reimbursing the amounts paid for the registration purchase.
- No street sales or unauthorized advertising. Street sales and the distribution of unauthorized advertising are prohibited. In case of non-compliance, the Organization may withdraw the pass and require the person to leave the venue.
- Access with animals and vehicles. Access with animals is not allowed, except in legally prescribed cases. Bicycles, scooters, skateboards, and similar means of transport are also not allowed.
- **No smoking policy.** Smoking is not allowed inside or in closed areas.
- Limited capacity. The access to the trade show will be conditioned by the venue capacity.
